



Attention District 5 Voters

As non-residential tax payers that pays thousands of dollars in taxes to the county, we would like to inform you how the county is run.

In 2008, we requested for Mayhaw Road to be closed due to vandalism, cows shot, fences/cross fences cut in order to gain access to anhydrous ammonia that is used in making drugs. We also had 70 feet of pivot extending across the road. Closure of the road was finalized in January 2009 after certified letters were sent to all landowners by county attorney, Toni Sawyer and legal notice run in the Cordele Dispatch.

On October 6, 2015, the regular commissioner's meeting was held. Placed on the agenda was an item that was controversial at the least. A group called one of the commissioner's and requested to be heard to give cause to reopen Mayhaw Road that they alleged had been illegally closed since January 2009. A certain commissioner, who had personal interest in reopening the road, never informed the other landowner's that this issue was on the agenda, so they could defend their rights. In a unanimous vote, the road was reopened even after Chairman Brown stated he remembered there were no opposition to close the road.

If not for a citizen at the meeting, calling us none of the other landowners would have known of the reopening of the road.

We had to contact a lawyer because they said it was a "done deal". No one ever took the time to see if the road had been closed legally or not.

All the documents pertaining to this road closure that the commissioner's office is required to keep, seemingly disappeared according to the county manager. I had to search and locate the documents myself through the Cordele Dispatch and going to the courthouse, taking hours of my time and money. We requested, through our lawyer, to be placed on the agenda for the November 3, 2015 meeting, we were informed by Toni Sawyer that this issue would not be discussed at that meeting. We attended the meeting anyway and were allowed to request the reclosure of Mayhaw Road.

In the December 1, 2015 meeting, Toni Sawyer, county lawyer, said the road was closed legally and what the commissioners had done was invalid but to clear the record they were told to rescind the vote. Motion was made to close Mayhaw Road and passed unanimously.

Really? How many times does this happen and no one knows what is going on? We were out our lawyer fees, slandered in the meetings and then told to "just act like it never happened"!

Is this the type of commissioner you want running the county and spending your money?

How many times are deals made to benefit one of the commissioners or one of their family members?




.22 Rimfire Competition
